SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal

fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Mechanicville City School District will utilize the funds to implement supports to ensure in-person learning for all students everyday as per the most recent guidance received. The funds will assist with student transitions back to the classroom and provide necessary support both academically and socially emotionally to ensure students' needs are met. Resources and support are being added which will enable students to be engaged, present, and learning everyday in a safe and supportive environment.

4. In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.

The Mechanicville City School District will be utilizing data tracking to identify students needs both academically and socially emotionally. i-Ready diagnostic tools will be utilized quarterly by all students in grades K-12 to determine students' needs in the areas of Math and English Language Arts. These assessments will identify strengths and weaknesses in specific areas which will allow for support staff to provide targeted interventions in the areas of deficit. Students progress will be tracked and data collected to ensure progress in the deficit areas. To ensure students' needs are being met on a social emotional level students will be screened at the beginning of the school year, with parent permission, utilizing a trauma inventory. In addition teachers will be trained in identifying the signs of trauma and next steps. The Mechanicville City School DIstrict will be implementing Multi-Tiered Systems of Supports (MTSS) to ensure the needs of the whole child are met. Data collection forms for referrals have been designed and include progress monitoring components to ensure data of supports and interventions is accurately documented. Support staff including a MTSS Coordinator and Trauma Informed Specialist will be a crucial component in monitoring student progress, supports, and interventions.

Mechanicville City School District will utilize the reserve funds to address the academic impact of lost instructional time by implementing summer enrichment academies and afterschool programs at all levels. Summer enrichment academies will utilize i-ready assessment data to target students performing below grade level. These students will be offered to engage in a 6-week intensive hands-on learning program designed to address academic deficiencies. Students will be provided transportation to the program in addition to meals supplied by Saratoga County. Students will be grouped in grade level brands with common deficits. The intensive program will focus on skill deficits and monitor data to ensure progress in the deficit areas. After School programs will be implemented to engage students in hands-on learning after school hours to reinforce skills in a small group setting. Data will be collected on student participation, attendance, and skill improvement.

In addition support staff and programs have been designed to assist students during the school year. Writers Workshop will be implemented in Kindergarten through 3rd grade for all students to provide a foundation for writing skills. This program and teacher will supplement the English Language Arts Curriculum and provide extra support in skill development. At the middle school level an at-risk program will be implemented. The program targets students who have been disengaged from learning during the pandemic and provides academic and social emotional support in the classroom to re-engage students.

The Mechanicville City School District will expend the remaining funds on professional development for staff to ensure they are provided the necessary tools to meet students at their level both educationally and socially emotionally.
